Title: AN ACT CONCERNING CHRONIC ABSENTEEISM.

Statement of Purpose: To expand the Probate Court Truancy Clinic program to include alliance districts, to require school districts that have high rates of chronic absenteeism to establish a district school attendance review team, to require the Department of Education to develop a chronic absenteeism prevention and intervention plan, to require the State Board of Education to define "disciplinary absence" and to require boards of education to report data relating to student attendance.
