Title: AN ACT CONCERNING THE PALLIATIVE USE OF MARIJUANA.

Statement of Purpose: To: (1) Provide for licensure of medical marijuana laboratories; (2) provide for the establishment and approval of medical marijuana research programs; (3) provide legal immunity to nurses who administer medical marijuana; (4) allow licensed producers and dispensary facilities to sell and transport medical marijuana to licensed laboratories and health care facilities; (5) expand the definition of "qualifying patient"; and (6) ease restrictions on the membership of the Board of Physicians.
