Title: AN ACT AMENDING THE CHARTER OF THE METROPOLITAN DISTRICT IN HARTFORD COUNTY AND EXTENDING THE MATURITY DATE FOR MUNICIPAL SEWERAGE SYSTEM BONDS.

Statement of Purpose: To (1) allow the Metropolitan District Commission to post certain notices by newspaper or online, (2) increase the threshold for appropriations that trigger certain voting requirements, (3) increase from one to two years the date by which the district must file certain liens with a town clerk, and (4) increase the maturity period for bonds for municipal sewerage systems from thirty to forty years.
