Title: AN ACT CONCERNING A STUDY OF THE SEXUAL OFFENDER REGISTRATION SYSTEM.

Statement of Purpose: To amend Connecticut's sex offender registry laws to ensure Connecticut law is compliant with the Adam Walsh Child Protection and Safety Act of 2006, to require that convicted sexual offenders reside at least one thousand feet away from a school or child care center and to provide information to potential host communities about proposed reentry housing.
