ORDER

The following order is entered in the above matter:

ORDER:

1. On April 21, 2010, the law firm of Hall Johnson LLC entered its appearance for both plaintiffs herein, Sylvester Traylor, Administrator of the Estate of Robert Mae Traylor and Sylvester Traylor, individually.
2. On July 6, 2010, Sylvester Traylor, in his individual capacity, filed an "in addition to" appearance, i.e., his own pro se appearance in addition to the appearance of Hall Johnson LLC then on file.
3. This created a "hybrid representation" situation.
4. On July 15, 2010, the court entered an order [364] re the hybrid representation; the bottom line thereof stated:
"[T]he plaintiff, Sylvester Traylor, is barred from representing himself until further order of this court."
5. On August 30, 2010, Sylvester Traylor filed a pro se "in place of" appearance, this appearance to be in place of the appearance of Hall Johnson LLC for Sylvester Traylor, individually, then on file.
6. To this date, no objection to the "in place of" appearance has been filed.
7. The August 30, 2010 "in place of" appearance became effective this date. P.B. §§ 3-8 and 3-9.

WHEREFORE, the July 15, 2010 order [364] barring Sylvester Traylor from representing himself is dissolved.
