

**To the Public Health Committee
In SUPPORT of Raised Bill 5915:
An Act Concerning the Practice of Classical Homeopathy
For February 23, 2015**

My name is Abby Beale, a nationally certified classical homeopath who lives in Wallingford. I also represent Homeopathy for Connecticut, a group of natural health conscious individuals committed to improving access to highly qualified homeopaths in Connecticut. I am writing in **support of Raised Bill 5915: An Act Concerning the Practice of Classical Homeopathy.**

Many of you reading this may not be familiar with homeopathy but homeopathy is natural, safe, inexpensive and used by over 200 million people all over the world. It is widely used in Europe, India, Russia, and many other countries.

It is safe to take alongside pharmaceuticals with NO interaction, unlike some herbs and supplements. It is routinely given to men, women, children, infants, pregnant women, and pets. Homeopathic remedies are sold in CT over the counter and regulated by the FDA.

I learned about homeopathy when my son was 9 months old and suffering from repeated ear infections. After many unsuccessful courses of antibiotics, his ear infections persisted. I decided to look for other options and found a homeopath. My son was given one homeopathic remedy and he never had another ear infection again. It was amazing with him and I see happenings like that with my clients now.

It took me over 11 years to complete the requirements for becoming a nationally certified classical homeopath (CCH designation). You can compare the CCH to the CPA for Accountants or a CFP for Financial Planners. I was hopeful that by the time I completed my training I could practice in CT but due to an 1893 law that says only medical doctors can practice here, I've had to open up a practice in Massachusetts instead. I love the practice of homeopathy but it is certainly a challenge to build a practice in a place you don't know anyone or have history with. I'd like to bring my skills back to CT.

So who comes to a homeopath? Typically it's people who don't like taking a lot of pharmaceutical drugs, or those who prefer a more natural approach to their healthcare or those who have been through the medical system and there is no other solution for them. By allowing nationally certified classical homeopaths the legal ability to practice here, there will be a larger selection of highly qualified practitioners for them to choose from.

So what would your experience be like going to a homeopath? If you came to me, for example, with a chronic condition like frequent headaches, you would first be required to sign a consent form (see attached). It says I am not a physician and you should have one, my services are not regulated by the state, a description of the services I render, a brief explanation of the theory of homeopathy and a brief bio of my background and training. The Council for Homeopathic Certification requires those practitioners with the CCH to have clients sign this consent before working with them.

Once signed, we would talk for as long as two hours where I would want to find out all about the headaches, like exactly where the pain is, what the pain feels like, what makes them better or worse, when they started, and more. This is why when you say "I have headaches", a homeopath doesn't suggest "X". With homeopathy, there isn't just one remedy for "headaches" there are many. *A remedy is highly individualized based on the expressing symptoms of the person who has the headaches.*

I then take the discernible symptoms and put them together like a puzzle matching it to a similar homeopathic remedy. You would be given a remedy and we'd schedule a follow up about a month later. I am accessible by phone and return calls within the same day or next latest. So my job is to select the best homeopathic remedy for YOU and to follow your progress. Unlike a medical doctor, I don't diagnose disease, administer or dispense legend drugs or controlled substances, engage in surgery or any in practices that invade the human body.

To become a CCH, I have completed 470 **more homeopathic** classroom hours than is required of a medical doctor in CT and 356 **more** than a naturopath. I have **300 more** homeopathic clinical hours than a medical doctor and **318 more** than a naturopath. (I am attaching a comparison document for your review) I firmly believe CCH's are well-qualified to practice homeopathy.

Currently in CT there are **only eight** registered medical doctors allowed to practice homeopathy of which only **two are practicing full-time** and **four are close to retirement** age. Additionally, naturopaths can prescribe homeopathic remedies as part of their practice but most do not major in it like the nationally certified classical homeopaths do.

I urge you to support the Raised Bill #5915. CT needs to give its residents more access to high quality homeopathic care. I would be happy to answer any questions you might have by contacting me at Abbylearn@gmail.com or 203-530-3367 with any questions.


