

the temperature is warm enough to accommodate the activities with comfort. Programs that serve exclusively school age children may utilize program space with lighting less than the fifty (50) foot candles and thirty (30) foot candles required pursuant to section 19a-79-7a(e)(9) provided the lighting is bright enough to accommodate the activities with comfort.

Programs located in a public school or private school in compliance with section 10-188 of the Connecticut General Statutes and approved by the State Board of Education or accredited by an accredited agency recognized by the State Board of Education are not required to verify compliance with the water testing requirements of 19a-79-7a(c).

Programs that are located in a facility that is subject to the requirements related to radon testing in school buildings pursuant to section 10-220 of Connecticut General Statutes are not required to verify compliance with the radon testing requirement of 19a-79-7a(e)(17).

The Commission will implement and operate under these regulations upon the development of software necessary to make these regulations operative.

Statement of purpose: These regulations establish the standards and practices required for the creation and submission of state agency Equal Employment Opportunity Plans.

Comment period: Persons wishing to present their views and arguments regarding these regulations are invited to do so in writing within thirty (30) days of publication of this notice.
