### **NOTICE OF INTENT TO AMEND REGULATION**

In accordance with the provisions of subsection (a) of Section 4-168 of the Connecticut General Statutes, notice is hereby given that the Commissioner of Motor Vehicles, pursuant to the authority of section 14-137a of the Connecticut General Statutes, proposes to adopt this amendment concerning the assessment of points against an operator's license for motor vehicle law violations.

**Statement of purpose:** The purpose of this proposal is to correct a drafting error that occurred unnoticed as the regulation was being amended earlier in 2014. The current regulation identifies the numerous statutory references that trigger the assessment of points against an operator's license and which are accompanied by a brief description of each moving violation. The proposal corrects the erroneous statutory citation so that it matches the narrative of the moving violation found in the regulation. This proposal is technical in nature and has no legal impact to the public.
