- 8 "Sec. 501. (*Effective July 1, 2016*) Reductions to appropriations made
9 in section 1 of this act in the amount of \$1,650,000 to the Board of

10 Regents for Higher Education, for Community Technical College
 11 System, and in the amount of \$1,650,000 to the Board of Regents for
 12 Higher Education, for Connecticut State University, shall be applied to
 13 reduce administrative costs in said Board of Regents for the fiscal year
 14 ending June 30, 2017.

15 Sec. 502. (*Effective July 1, 2016*) Notwithstanding the provisions of
 16 section 3-69a of the general statutes, for the fiscal year ending June 30,
 17 2017, no portion of the funds received under part III of chapter 32 of
 18 the general statutes that are deposited in the General Fund shall be
 19 credited to the Citizens' Election Fund established in section 9-701 of
 20 the general statutes.

21 Sec. 503. (*Effective July 1, 2016*) Notwithstanding any provision of the
 22 general statutes, in addition to any other state grant received by the
 23 following municipalities, each such municipality shall receive an
 24 additional grant during the fiscal year ending June 30, 2017, to be
 25 payable as follows:
