80 chapter 157 of the general statutes, no grant under the Citizens'
81 Election Program shall be issued to the candidate committee of any

82 candidate for nomination or election to office in 2016.

83 Sec. 502. (*Effective July 1, 2016*) Notwithstanding any provision of the
84 general statutes, all moneys contained in the Citizens' Election Fund,
85 as established in section 9-701 of the general statutes, shall be credited
86 to the resources of the General Fund for the fiscal year ending June 30,
87 2017.

88 Sec. 503. (*Effective July 1, 2016*) Notwithstanding the provisions of
89 section 3-69a of the general statutes, for the fiscal year ending June 30,
90 2017, no funds received under part III of chapter 32 of the general
91 statutes shall be credited to the resources of the Citizens' Election
92 Fund, as established in section 9-701 of the general statutes."
