23 general statutes, the sum of \$3,400,000 shall be transferred from the  
24 Citizens' Election Fund and credited to the resources of the General Fund  
25 for the fiscal year ending June 30, 2017, for the purpose of restoring  
26 certain budgetary cuts made in section 1 of this act. Grants paid out of the  
27 Citizens' Election Fund for the fiscal year ending June 30, 2017, shall be  
28 reduced proportionally by the amount of \$3,400,000."
