Title: AN ACT CONCERNING THE NOTIFICATION OF DEPARTMENT OF ADMINISTRATIVE SERVICES PROJECTS, THE DEFINITION OF "PROJECT" AND REPEALING A PROVISION CONCERNING STATE AGENCY REPORTING OF CERTAIN CONTRACTOR INFORMATION.

Statement of Purpose: To require the Commissioner of Administrative Services to post notice of projects on the State Contracting Portal rather than in a newspaper advertisement, to raise the threshold for projects from those exceeding three hundred thousand dollars to those exceeding five hundred thousand dollars, to repeal a provision requiring notification to the Department of Revenue Services regarding certain contractor information for contracts purchasing goods or services or leases with the state and to make technical and conforming changes.
