Title: AN ACT CONCERNING THE USE OF DRONES.

Statement of Purpose: To (1) establish the crime of using computer software or technology, including a drone, which allows someone who is not physically present to release tear gas or control a deadly weapon, explosive or incendiary device, (2) limit the use of a drone by law enforcement and other state agencies, and (3) establish retention and destruction requirements for information collected by law enforcement using drones.
