Title: AN ACT CONCERNING DISCLOSURE OF COORDINATED AND INDEPENDENT SPENDING IN CAMPAIGN FINANCE.

Statement of Purpose: To (1) increase disclosure with respect to independent expenditures, (2) clarify distinctions between coordinated and independent spending, enhancing enforcement of campaign finance laws, and (3) conform statutes to rulings by the United States Supreme Court and the Second Circuit Court of Appeals.
