**Title:** AN ACT CONCERNING REGIONAL EDUCATION.

**Statement of Purpose:** To require the Department of Administrative Services to conduct a regional school capacity assessment as part of the application process for school building projects, to authorize regional educational service centers to enter into agreements with school districts to provide administrative services, and to permit school districts to use the aggregate expenditure data of a cooperative arrangement for purposes of reporting requirements.
