Title: AN ACT CONCERNING DETAINED YOUTH.

Statement of Purpose: To improve the behavioral and mental health services provided to youth in the custody of the Department of Children and Families and the Department of Correction by requiring such departments to limit instances of seclusion and restraint to individuals twenty years of age and older, to study and report upon youths held in secure detention and correctional facilities and to adopt certain performance-based standards for such facilities.
