Title: AN ACT CONCERNING VETERANS, DISCRIMINATORY PRACTICES AND ORDERS OF THE COMMISSION ON HUMAN RIGHTS AND OPPORTUNITIES IN EMPLOYMENT DISCRIMINATION CASES.

Statement of Purpose: To (1) protect against certain discriminatory practices on the basis of an individual's status as a veteran, and (2) require the presiding officer at a hearing conducted upon a complaint of a discriminatory employment practice, and upon a finding of such practice, to determine the full extent of damages suffered and costs incurred by the complainant.
