Title: AN ACT CONCERNING THE APPLICABILITY AND PROVISION OF TRAINING FOR REGISTRARS OF VOTERS.

Statement of Purpose: To eliminate (1) the requirement that each registrar, or a deputy or assistant designated by such registrar, attend the Secretary of State's election law and procedures training program, and (2) the Secretary of State's authority to delegate the conduct of certain other training for purposes of certification to a third party.
