Title: AN ACT CONCERNING SERVICES FOR INDIVIDUALS WITH INTELLECTUAL DISABILITY.

Statement of Purpose: To require the Commissioner of Developmental Services to take certain actions relating to the Department of Developmental Services' waiting list, to require the Secretary of the Office of Policy and Management to consult with stakeholders on a plan to close facilities operated by the department and to require advance notice when an individual with intellectual disability's eligibility for state-assisted care will end.
