**Title:** AN ACT CONCERNING A STUDY OF THE BENEFITS PROVIDED PURSUANT TO THE TEMPORARY FAMILY ASSISTANCE PROGRAM.

**Statement of Purpose:** To allow certain families who earn not more than one hundred fifty per cent of the federal poverty level to receive temporary family assistance, to allow for a one-time benefit to be paid to individuals who have exhausted temporary family assistance but have subsequently secured employment, and to allow individuals receiving unemployment benefits to continue to receive a portion of such benefits upon accepting employment at a rate lower than their unemployment benefit rate.
