Title: AN ACT CONCERNING ELECTRONIC FILING OF CAMPAIGN REPORTS.

Statement of Purpose: To (1) require electronic filing of campaign finance disclosure statements with the State Elections Enforcement Commission for certain committees that raise or spend one thousand dollars or more, except when the commission waives such requirement on a demonstration of good cause, and (2) give the commission discretion in imposing fees for late filing of such statements in light of evidence that such statements should reasonably have been delivered and received by said commission by the applicable deadline.
