Statement of Purpose: To (1) remove the Connecticut Green Bank from Connecticut Innovations, Incorporated, (2) give the Connecticut Green Bank additional powers, (3) make changes regarding the priority of the benefit assessments lien under the Connecticut Green Bank's commercial sustainable energy program, (4) make changes to the solar home renewable energy credit program, and (5) make other technical and conforming changes.
