Title: AN ACT CONCERNING THE CONNECTICUT BIOSCIENCE INNOVATION FUND AND INVESTMENTS BY CONNECTICUT INNOVATIONS, INCORPORATED.

Statement of Purpose: To allow Connecticut Innovations, Incorporated, to invest in private equity funds, to allow funds in the Connecticut Bioscience Innovation Fund to be invested prior to being awarded as financial assistance, to redefine early-stage business and allow follow-on financial assistance and to make loan repayments and other earnings from bioscience fund investments to be used by Connecticut Innovations, Incorporated, as unrestricted funds.
