**Title:** AN ACT CONCERNING RESIDENTIAL WATER RATES, PUBLIC DRINKING WATER SUPPLY EMERGENCIES AND SELLERS OF BOTTLED WATER.

**Statement of Purpose:** To prioritize residential consumer water sales during public drinking water supply emergencies, to prohibit sellers of bottled water from charging commercial users less than residential consumers and to ensure sellers who export bottled water out of the state do not pay lower sewer rates than residential consumers.
