Substitute House Joint Resolution No. 133

*House of Representatives, April 14, 2016*

The Committee on Judiciary reported through REP. TONG of the 147th Dist., Chairperson of the Committee on the part of the House, that the substitute resolution ought to be adopted.

***RESOLUTION VACATING THE DECISION OF THE CLAIMS COMMISSIONER TO DISMISS THE CLAIM AGAINST THE STATE OF SANDRO SOLLA AND REMANDING THE CLAIM TO THE CLAIMS COMMISSIONER FOR A HEARING ON THE MERITS.***

Resolved by this Assembly:

- 1 That the decision of the Claims Commissioner, file number 23965 of
- 2 said commissioner, ordering the dismissal of the claim against the state
- 3 in excess of twenty thousand dollars of Sandro Solla, is vacated and
- 4 the claim is remanded to the Claims Commissioner for a hearing on
- 5 the merits.
