"AN ACT CONCERNING THE INDEMNIFICATION OF LAW ENFORCEMENT PROFESSIONALS."

1 After the last section, add the following and renumber sections and
2 internal references accordingly:

3 "Sec. 501. Subsection (d) of section 22a-245 of the general statutes is
4 repealed and the following is substituted in lieu thereof (*Effective July*
5 *1, 2016*):

6 (d) In addition to the refund value of a beverage container, a
7 distributor shall pay to any dealer or operator of a redemption center a
8 handling fee of at least [one] three and one-half cents for each beverage
9 container of beer or other malt beverage, [and two cents for each
10 beverage container of] mineral [waters] water, soda water and similar
11 carbonated soft drinks or noncarbonated beverage returned for
12 redemption. A distributor shall not be required to pay to a
13 manufacturer the refund value of a nonrefillable beverage container."

This act shall take effect as follows and shall amend the following sections:		
Sec. 501	<i>July 1, 2016</i>	22a-245(d)
