**AN ACT CONCERNING THE CREATION OF A SMALL BUSINESS
HOTLINE.**

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 That section 32-9n of the general statutes be amended to establish
2 within the Office of Small Business Affairs a state-wide small business
3 hotline providing prospective and existing small business owners with
4 individualized information and guidance regarding business
5 formation and development, technical and financial assistance from
6 the state and networking resources.
