AN ACT CODIFYING FEDERAL TITLE IX PROTECTIONS.

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. Subsection (f) of section 10a-55m of the general statutes is
2 repealed and the following is substituted in lieu thereof (*Effective July*
3 *1, 2017*):

4 (f) Not later than October 1, [2015] 2017, and annually thereafter,
5 each institution of higher education shall report to the joint standing
6 committee of the General Assembly having cognizance of matters
7 relating to higher education, in accordance with the provisions of
8 section 11-4a, concerning, for the immediately preceding calendar year,
9 (1) a copy of its most recent policies regarding sexual assault, stalking
10 and intimate partner violence adopted in accordance with subsection
11 (b) of this section, or any revisions thereto, (2) a copy of its most recent
12 concise written notification of the rights and options of a student or
13 employee who reports or discloses an alleged violation of its sexual
14 assault, stalking and intimate partner violence policy or policies
15 required pursuant to subsection (e) of this section, (3) the number and

16 type of sexual assault, stalking and intimate partner violence
17 prevention, awareness and risk reduction programs at the institution,
18 (4) the type of sexual assault, stalking and intimate partner violence
19 prevention and awareness campaigns held by the institution, (5) the
20 number of incidences of sexual assault, stalking and intimate partner
21 violence reported or disclosed to such institution, (6) the number of
22 confidential or anonymous reports or disclosures to the institution of
23 sexual assault, stalking and intimate partner violence, (7) the number
24 of disciplinary cases at the institution related to sexual assault, stalking
25 and intimate partner violence, [and] (8) the final outcome of all
26 disciplinary cases at the institution related to sexual assault, stalking
27 and intimate partner violence, including, but not limited to, the
28 outcome of any appeals of such final outcome, to the extent reporting
29 on such outcomes does not conflict with federal law, and (9) an
30 analysis of any impact to the number of incidences of sexual assault,
31 stalking and intimate partner violence reported or disclosed to such
32 institution resulting from any amendments to such policies regarding
33 sexual assault, stalking and intimate partner violence as a result of
34 guidance received from a state or federal agency or changes in state or
35 federal law, including, but not limited to, statutes, regulations, court
36 decisions or executive orders.

This act shall take effect as follows and shall amend the following sections:
