"AN ACT PROVIDING FOR THE CONTINUED OPERATION OF ESSENTIAL FUNCTIONS OF THE STATE."

1 After the last section, add the following and renumber sections and
2 internal references accordingly:

3 "Sec. 501. (*Effective from passage*) (a) The following sums are
4 appropriated from the General Fund, for the fiscal year ending June 30,
5 2018, to the following agencies for the purposes indicated: \$8,765,468
6 to The University of Connecticut to restore funding for Next
7 Generation Connecticut; \$4,584,084 to Connecticut State Colleges and
8 Universities to restore funding for Developmental Services; and
9 \$35,345,804 to the Department of Education for Roberta B. Willis
10 Scholarship Fund.

11 (b) The following sums are appropriated from the General Fund, for
12 the fiscal year ending June 30, 2019, to the following agencies for the
13 purposes indicated: \$8,676,928 to The University of Connecticut to
14 restore funding for Next Generation Connecticut; \$4,584,084 to
15 Connecticut State Colleges and Universities to restore funding for
16 Developmental Services; and \$26,710,910 to the Department of
17 Education for Roberta B. Willis Scholarship Fund."
