**Title:** AN ACT CONCERNING CAMPAIGN FINANCE REFORM.

**Statement of Purpose:** To (1) create bright lines between coordinated and independent spending, (2) address in statute independent expenditure political committees, (3) increase disclosure of sources of funds used for independent expenditures, (4) require board of governance authorization before certain entities make certain campaign-related disbursements of funds and disclosure of such disbursements to shareholders, (5) prohibit independent expenditures or covered transfers by foreign-influenced entities, and (6) impose limits on covered transfers.
