Title: AN ACT INCREASING THE MINIMUM AMOUNT OF INSURANCE COVERAGE REQUIRED TO ISSUE A MOTOR VEHICLE OPERATOR'S LICENSE OR CERTIFICATE OF MOTOR VEHICLE REGISTRATION.

Statement of Purpose: To specify that religious nonmedical providers may be included as providers by health insurance companies, health care centers, hospital service corporations, medical service corporations and other entities that deliver, issue for delivery, renew, amend or continue health insurance policies or health benefit plans in this state.
