Title: AN ACT ESTABLISHING A WORKING GROUP TO REVIEW THE LICENSURE AND CERTIFICATION PROCESS FOR CERTAIN NONPROFIT COMMUNITY PROVIDERS.

Statement of Purpose: To reduce costs for nonprofit providers by providing a means for them to forgo duplicative state licensing requirements for certain license and certificate renewals if they are accredited by an accepted national accrediting body that has requirements more stringent than the state's.
