**Title:** AN ACT CONCERNING THE AFFORDABLE HOUSING LAND USE APPEALS PROCEDURE.

**Statement of Purpose:** To lower the minimum number of housing unit-equivalent points needed for a moratorium, expand the unit types that count towards a moratorium and redefine median income for purposes of the incentive housing zone statutes, and to sunset such changes after five years.
