Title: AN ACT CONCERNING THE DEPARTMENT OF CHILDREN AND FAMILIES' STANDARDS AND REPORTING REQUIREMENTS.

Statement of Purpose: To (1) require the Commissioner of Children and Families to establish protocols for the investigation of reports of child abuse or neglect of children from birth to three years of age, (2) issue certain reports to the Superior Court when a child or youth is committed to such commissioner, and (3) report annually to the joint standing committee of the General Assembly having cognizance of matters relating to children regarding foster care licensing practices.
