Title: AN ACT MAKING REVISIONS TO STATUTES CONCERNING THE DEPARTMENT OF ADMINISTRATIVE SERVICES.

Statement of Purpose: To make revisions to a statute concerning the State Marshal Commission; change the deadline for municipalities to notify the Department of Administrative Services of their interest in purchasing surplus real property; permit the department to determine the best method of disposing of such property, including offering it to abutting landowners; expand the department's authority to grant easements; expand the existing exemption from certain emission, gas mileage and other standards for state fleet vehicles to include all emergency vehicles; modify the threshold for separate specifications for classes of work; and make other minor revisions.
