

Collective Bargaining Agreements Presented to the General Assembly 2002-2017

Issue

This report identifies state employee collective bargaining agreements presented to the General Assembly from 2002 to May 2017 and states how they were approved. See OLR Report [2002-R-0150](#) for a description of the agreements presented to the General Assembly from 1991 to 2001.

Legislative Approval of Collective Bargaining Agreements

By law, the legislature must approve or reject each state employee collective bargaining agreement, whether negotiated or imposed on the parties by an arbitrator's award. Under [CGS § 5-278](#), collective bargaining agreements and interest arbitration awards must be filed with House and Senate clerks. Once an agreement is filed, the legislature's Joint Rules require the House speaker and Senate president pro tempore to have resolutions proposing approval prepared within two calendar days. Once the resolutions are filed, they must be referred to the Appropriations Committee, which must hold a hearing and report on the resolutions within 15 days. If the committee takes no action within those 15 days, the resolutions are deemed approved by the committee. In some instances, legislative leaders have emergency certified a resolution, allowing it to bypass the Appropriations Committee process and proceed straight to the floor.

The law requires a majority vote of each chamber to approve an agreement or award. But, if a chamber fails to bring the matter to a vote within 30 days of filing, that body is deemed to have approved the agreement. Rejecting an agreement requires a majority vote in either chamber. But, rejecting an arbitrator's award requires a determination that there are insufficient funds for implementation and a two-thirds vote in either chamber.

Since 2002, the General Assembly has approved 189 of the 190 agreements presented to it (one agreement was withdrawn after it was presented in 2016). These include major pension and health care agreements with the State Employees Bargaining Agent Coalition (SEBAC), wage and hour agreements with individual bargaining units, arbitration awards, and numerous stipulated agreements and memoranda of understanding that make relatively minor revisions to existing bargaining unit contracts. (SEBAC is a collation that represents 15 state employee unions that include more than 30 bargaining units representing roughly 85% of all state employees. By law, state employee pension and healthcare benefits are negotiated through SEBAC.)

Of these 189 agreements, the legislature approved:

- 124 through no action by either chamber (including the 2011 SEBAC agreement and 32 additional agreements with individual collective bargaining units that were approved without action under a provision of [PA 11-1, June Special Session](#));
- 55 through affirmative approval in both chambers (including 29 agreements with individual collective bargaining units that were approved as part of the same resolutions that approved the 2009 SEBAC agreement); and
- 10 through affirmative approval in the Senate and no action in the House.

Table 1 lists the agreements and awards presented to the legislature since 2002. We have arranged them in reverse chronological order and identified their House and Senate Resolution numbers and each agreement's title. The final column indicates how the contract was approved (except for the one that was withdrawn). Those listed as "no action" include resolutions recommitted to the Appropriations Committee without a vote in either chamber.
