**Title:** AN ACT CONCERNING THE PENALTY FOR TAILGATING AND CONOR'S LAW REGARDING PROTECTIVE HEADGEAR WHILE SKATEBOARDING, ROLLER SKATING AND IN-LINE SKATING.

**Statement of Purpose:** To (1) increase the penalty for failing to drive a reasonable distance apart from another motor vehicle if such failure results in an accident, (2) require children fifteen years of age or under to wear protective headgear when skateboarding, roller skating or in-line skating, and (3) permit the use of neighborhood electric vehicles on highways with an established speed limit of no more than thirty miles per hour.
