House Bill No. 5293

House of Representatives, April 10, 2018

The Committee on Public Health reported through REP. STEINBERG of the 136th Dist., Chairperson of the Committee on the part of the House, that the bill ought to pass.

AN ACT CONCERNING THE SALE OF ELECTRONIC NICOTINE DELIVERY SYSTEMS AND VAPOR PRODUCTS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (NEW) (Effective October 1, 2018) A retailer of electronic
- 2 nicotine delivery systems, as defined in section 19a-342a of the general
- 3 statutes, or vapor products, as defined in said section, shall comply
- 4 with the requirements set forth in 21 CFR 1140.14 and 21 CFR 1140.16,
- 5 as amended from time to time, for a direct, face-to-face exchange
- 6 between a retailer and the consumer in the sale of cigarettes and
- 7 smokeless tobacco products when the retailer is selling such electronic
- 8 nicotine delivery systems or vapor products.

This act shall take effect as follows and shall amend the following sections:

OLR Bill Analysis HB 5293

AN ACT CONCERNING THE SALE OF ELECTRONIC NICOTINE DELIVERY SYSTEMS AND VAPOR PRODUCTS.

SUMMARY

This bill requires retailers of e-cigarettes (i.e., electronic nicotine delivery systems or vapor products) to sell them to consumers only in direct, face-to-face transactions, as federal regulations require for the sale of cigarettes and smokeless tobacco products (21 C.F.R. §§ 1140.14 and 1140.16).

In doing so, the bill prohibits e-cigarette sales (1) online or (2) through self-service displays or vending machines, except in facilities where the retailer ensures that no person under age 18 is present, or permitted to enter, at any time.

Existing law, unchanged by the bill, prohibits selling e-cigarettes to minors.
