"AN ACT MANDATING INSURANCE COVERAGE OF ESSENTIAL HEALTH BENEFITS AND EXPANDING MANDATED HEALTH BENEFITS FOR WOMEN, CHILDREN AND ADOLESCENTS."

1 After the last section, add the following and renumber sections and
2 internal references accordingly:

3 "Sec. 501. Section 2-24 of the 2018 supplement to the general statutes
4 is repealed and the following is substituted in lieu thereof (*Effective*
5 *October 1, 2018*):

6 (a) The words "State of Connecticut" shall be printed at the head of
7 each bill and document printed by order of the General Assembly, or
8 either house thereof, and on its title page or cover, if any.

9 (b) Before printed, electronic or photographic copies of an original
10 bill are made, the bill shall be endorsed with (1) the date of its
11 introduction; (2) its number; (3) the name of the member or committee
12 introducing it; and (4) the name of the committee to which it was
13 referred.

14 (c) Copies of bills or resolutions printed or produced electronically
15 after favorable report by a committee or reprinted or produced
16 electronically after amendment on the third reading, i.e., files, shall
17 bear: [the]

18 (1) The file number of such bill or resolution, placed conspicuously
19 at the head of the same, which file number shall be assigned by the
20 Legislative Commissioners' Office in the order printed or produced; [,
21 the]

22 (2) Both the number and title of the bill [, the] if the chairpersons
23 and ranking members of the reporting committee have approved such
24 title, or only the number of the bill if such chairpersons and ranking
25 members have not approved such title; and

26 (3) The name of the committee to which it was referred, the date and
27 nature of the committee's report, in any case where the bill, if passed,
28 would require the expenditure of state or municipal funds or affect
29 state or municipal revenue, a fiscal note, including an estimate of the
30 cost or of the revenue impact shall be appended thereto, and, in any
31 case where the bill, if passed, would have a financial impact on electric
32 ratepayers, a ratepayer impact statement, as described in subsection (b)
33 of section 2-24a.

34 (d) When a bill or resolution is accompanied with a report of a
35 committee, other than a recommendation that it ought or ought not to
36 pass, it shall then have an additional endorsement, as follows:
37 "Accompanied by special report, No.-". Bills shall be designated in the
38 calendar of each house by their file numbers, as well as by the titles
39 and numbers of the bills."
