SPEAKER ARESIMOWICZ (30TH):

Please come to order. Will members, staff and guests please rise. Direct your attention to the Dias, where Guest Chaplain, Representative Carpino will lead us in prayer.

GUEST CHAPLAIN REPRESENTATIVE CARPINO (32ND):

Let us pray. Dear Lord, this year brings us many challenges and expectations. Help us to sort out the needs of our State and her people, and grant us sound judgment, so that the decisions we make will benefit our faithful constituents. Amen.

REP. GIBSON (15TH):

(All) I pledge allegiance to the flag of the United States of America and to the Republic for which it stands, one nation under God, indivisible, with liberty and justice for all.

SPEAKER ARESIMOWICZ (30TH):

Is there any business on the Clerk's desk?

CLERK:

SPEAKER ARESIMOWICZ (30TH):

SPEAKER ARESIMOWICZ (30TH):

Good afternoon, Representative Ritter.

REP. RITTER (1ST):

Good afternoon, Mr. Speaker. I move that we waive the reading of the list of the bills and the bills be referred to the committees indicated.

SPEAKER ARESIMOWICZ (30TH):

So noted.

Thank you, Mr. Speaker. I do believe that everybody in this Chamber knows that I have been passionate about the link between animal cruelty and

future violent behavior. I also know we had a terrible tragedy in Florida, which was preceded by animal cruelty and that also happened in Columbine in 1999.

We, in Connecticut, have Desmond's Law, where we have animal advocates, UConn law students in court, who are representing animals that have egregious abuse, so that instead of people that perpetrate this violence get away with it -
SPEAKER ARESIMOWICZ (30TH):

(Gavel) I know everybody is getting settled in, before we start the business from the day, but the Representative does have the floor, if we can show her a little bit of respect and take our conversations to the hall.

Please proceed, Madam.

REP. URBAN (43RD):

Thank you, Mr. Speaker. So, I was talking about the link between animal cruelty and future violent behavior and the fact that 80 percent of school shooters have started by being cruel to animals. We have Desmond's law in Connecticut.

We're the only state in the country, the first, to have UConn law students in court so that we take violence against animals seriously.

Mr. Speaker, I'm so pleased to let the Chamber know that today I have been named by the Animal Legal Defense Fund as one of the top 10 defenders of animals in our country. And I plan on taking that as I leave this Chamber to the entire nation, so that we will no longer not take animal cruelty seriously and maybe save some children from being killed by school shooters.

SPEAKER ARESIMOWICZ (30TH):

The esteemed Deputy Speaker of the 110th

District, Representative Godfrey, for what purpose
do you rise, sir?

REP. GODFREY (110TH):

To make a motion, Mr. Speaker. I move we accept the House Committee's favorable report and adopt the resolution.

SPEAKER ARESIMOWICZ (30TH):

The question before the Chamber is on acceptance of the Joint Committee's favorable report and adoption of the resolution.

Representative Godfrey, you have the floor, sir.

REP. GODFREY (110TH):

Thank you, Mr. Speaker. For me this is a labor of love. I've known Tom Saadi, from Danbury. He doesn't quite live in my district, although I live in his. It's one of those magic moments of where the lines are drawn. I get to vote for him for city council. He can't vote for me for State

Representative because he doesn't live in my district, I live in his. But nonetheless, I've watched him over 25 years as he's really become an example of the American dream.

I first met him when he was starting, working actually in the legislative office building as an intern and then as a staff member rather, under Speaker Ritter, it's that long ago.

He went on to go to law school after having worked his way through Western Connecticut State
University. He is a product of Connecticut's higher education system. When he left here, he went to law school. He went to work for the Attorney General at the time, Dick Blumenthal, our good friend. He was an Assistant Attorney General. He was a special Assistant State's Attorney for the Office of the Attorney General. He, luckily for us, got a really good job with our Department of Veterans Affairs. He was a legislative liaison. We saw quite a bit of him. Then he became the Chief of Staff and General Counsel for the Department and since last fall, he's

been the Acting Commissioner. We're looking to make him Commissioner of the Department of Veterans

Affairs now.

He has an extensive resume, I'm not going to go over every detail, but he is a member of the Danbury City Council and has been for quite some time. He is also a serving member in the 411th Civil Affairs Battalion of the U.S. Army Reserve. He's a Major and has been a lawyer, an attorney, with the Judge Advocate Corps, serving there in the Army.

It really gives me great pleasure. I know his mom, he's been brought up right. His mother did a great job. He's a first-generation immigrant. His father immigrated to this country in the 1960s from Lebanon. And I can't say enough good things about Tom Saadi. So, I would encourage you all to join me in supporting this nomination and in voting yes on this resolution.

REP. WOOD (141ST):

Thank you, Mr. Speaker. And while I don't know Mr. Saadi's mother, I do know -- yet, I should say yet, I can understand why she parented him well.

And one of the joys of serving on executive nominees is meeting all the people that are willing to step up and serve, mostly on a volunteer basis, although this obviously is not. He was educated Western Connecticut, Quinnipiac School of Law -- SPEAKER ARESIMOWICZ (30TH):

You're welcome.

REP. WOOD (141ST):

I think particularly for this nomination, I would really like to request quiet in the Chamber.

This is a man who is serving our Veterans and we should all be listening to why he is qualified, more than qualified to do this. Thank you.

As I have mentioned, he was educated at Western Connecticut State University, Quinnipiac Law School. What struck me in the interview and meeting him in executive nominations was his humanity and how he is reaching out to all of the different stakeholders and making a difference in all of these Veterans' lives and it's critical in our state we have someone of this capacity and this humanity to do so.

There were many, many letters in strong support of Mr. Saadi for this position and I urge you all to join me in supporting this nomination.

Mr. Speaker, I speak in strong support of Mr. Saadi. I know Attorney Saadi personally. He's a man of his word. He's honest. He's humble. He's everything a public servant could be. He embodies what we want all commissioners to be. I strongly support his nomination.

SPEAKER ARESIMOWICZ (30TH):

Thank you, sir. Representative Carpino of the 32nd, you have the floor, Madam.

REP. CARPINO (32ND):

Thank you, Mr. Speaker. I've actually had the opportunity to work with Mr. Saadi over the last few years and someone I'm going to be proud to call Commissioner. Throughout the PRI process, we had some pretty major overhauls of the VA in Rocky Hill

REP. FERGUSON (138TH):

and he was on deck with any changes that we could make to really support our Veterans. Since then, I've still had the opportunity to continue working with him and whether it is a legislative proposal that might be a little prickly or whether it is saying hello to school children, bringing up Valentines for the Veterans, he's a wonderful man and I look forward to supporting him.

SPEAKER ARESIMOWICZ (30TH):

Thank you very much, Madam. Representative Ferguson of the 138th, you have the floor.

Thank you very much, Mr. Speaker. I've had the opportunity and the chance to work alongside Tom Saadi, back home in Danbury, and I have to echo what my colleagues have all said. Truly an experienced and dedicated public servant. We are very lucky to have him before us for consideration to become the next Commissioner for the Department of Veterans Affairs. He has a very impressive resume, is an honorable man who truly loves his country and will do an excellent job in this position, which he has

already done an excellent job as Acting Commissioner and I urge his strong support. Thank you very much, Mr. Speaker.

SPEAKER ARESIMOWICZ (30TH):

Thank you, sir. Representative Ferraro of the 117th, you have the floor, sir.

REP. FERRARO (117TH):

Thank you, Mr. Speaker. As a ranking member of the Veterans Committee, I've had a chance to work with Commissioner Saadi and I also, along with my colleagues, rise in strong support of his being appointed to this position. Thank you very much, Mr. Speaker.

SPEAKER ARESIMOWICZ (30TH):

Thank you, sir. Representative Smith of the 108th, you have the floor, sir.

REP. SMITH (108TH):

Good afternoon, Mr. Speaker, and thank you for the opportunity to speak in favor of this nomination. Mr. Saadi has served the City of Danbury so well for so many years and I'm so happy and pleased to hear that my colleagues are very much

in support of this nomination and I add my name to the list. Thank you, sir.

SPEAKER ARESIMOWICZ (30TH):

Thank you. Representative Vargas of the 6th District, you have the floor, sir.

REP. VARGAS (6TH):

Thank you, Mr. Speaker. As the House Chair of the Executive and Legislative Nominations Committee, I rise to support this nomination.

I've had the opportunity to meet Mr. Saadi, although briefly and recently and very rarely does one's background, passion and skills match so closely the position of Commissioner of Veterans Affairs. So, I believe the department will be in good hands. I'm glad to see my colleagues on both sides of the aisles are in support and I wanted to add my support to his nomination. Thank you. Taskforce, the Healthcare Access Commission. A

Commissioner of the Connecticut Department of Human

Resources. So, he's active in our community. He

impressed us with his demeanor and knowledge of the

law and I urge adoption.

SPEAKER ARESIMOWICZ (30TH):

Thank you very much, sir. Will you remark further? The ranking member of the Judiciary Committee, Representative Rebimbas, you have the floor, Madam.

REP. REBIMBAS (70TH):

Thank you, Mr. Speaker. Mr. Speaker, I do rise in support of the nominee before us in his reappointment. Certainly, the good Chairman highlighted all of his qualifications and this is an individual who has and continues to give back to the legal community. And I think anytime you have someone with these qualifications and experience, who is able to contribute in improving the system, it's certainly an asset to our bench. So, I do support in his renomination.

SPEAKER ARESIMOWICZ (30TH):

REP. ZIOBRON (34TH):

Thank you, Mr. Speaker, and good afternoon.

Mr. Speaker, I don't mean to bring brevity to this

issue, but I have no choice after hearing the

testimony from Judge Carroll yesterday in the

Appropriations Committee. And I think it's

appropriate to share his testimony in a snippet here

before the Chamber, if that's okay, Mr. Speaker?

Thank you.

Mr. Speaker, Judge Carroll yesterday in his testimony said this: In June of 2016, we had no choice but to involuntary reduce our workforce by 300 people. Essential staff were forced to leave the branch, judicial marshals, temporary assistant clerks who support our judges on the bench, adult and juvenile probation officers, family relation counselors, bail commissioners, juvenile detention officers were among those laid off or terminated.

We certainly did not desire to take this action, but

that was the only way for us to achieve \$15 million dollars in personal services savings. We did our best to transfer remaining staff to fill the gaps that resulted from the staff cuts, but problems were inevitable. Courtroom coverage by marshals were curtailed and judges were more frequently delayed in opening a court because of lack of support staff.

Mr. Speaker, I continue to raise the alarm -- SPEAKER ARESIMOWICZ (30TH):

(Gavel) Folks, we're not off to a good start.

This is only our first real day in session. I know there is a lot of staff in here. But if you're having conversations, please take them out in the hall. Representatives deserve to be heard by the people in the Chamber and right now, it's very difficult. We do have a Sergeant at Arms that will remove people from the Chamber. And I don't want to start that way.

So, please, show the Representative the proper respect by listening to what she has to say or any other Representative as they have the floor. Thank you and please proceed, Madam.

REP. ZIOBRON (34TH):

Well, thank you, Mr. Speaker. So, I just read Judge Carroll's testimony to the Appropriations Committee yesterday and I was just summarizing in my comments and summarization are this, Mr. Speaker, we continue to have a fiscal crisis in this state and by continuing to appoint and reappoint judges and ignore the fact that we have courtrooms without security, we have courtrooms without clerks, we have courtrooms that can't function without the support staff necessary, continues to concern me and for that reason, I'll be voting no. Thank you, Mr. Speaker.

SPEAKER ARESIMOWICZ (30TH):
