This bill would give the opportunity on all official state forms and applications to have a third check box.

Also for consistency, it should be included in the language of the bill, that mailings from the state addressed to the people recognized as neither M or F would be addressed as Mx instead of either Mr Ms or Mrs. Check the Merriam-Webster link. It is already being used in various states as per the links below.

We understand this implies electronic changes and will not be a costly update to the Department of Administrative Services, to the DMV, the SEEC, the DOT and other state agencies with their own forms and applications to update. Additionally it should be at no additional cost to anyone these changes serve.

This is why I am asking that you support this House Bill 5505, and give it the opportunity to get out of committee and help and support make its way up to the governor's desk. It is important that we not let anyone in our state feel left out and not recognized for who they are. It is of utter importance that all members of a community feel included, respected and loved.
