Statement of Purpose: To make revisions to the State Codes of Ethics concerning the scope of gift prohibitions, reporting of gifts, authority of the ethics enforcement officer, contracting with quasi-public agencies, activities involving consultants and independent contractors, findings of ethics violations, appropriating funds to reimburse credit card processing fees and the repeal of certain provisions.
