**Title:** AN ACT COMBATTING SEXUAL ASSAULT AND SEXUAL HARASSMENT.

**Statement of Purpose:** To: (1) Enhance employer-sponsored training on sexual harassment, (2) extend the statute of limitations applicable to certain personal injury actions involving sexual abuse, sexual exploitation and sexual assault, (3) increase penalties for sexually assaulting a mentally incapacitated person, and (4) eliminate or extend the statute of limitations for the prosecution of sexual assault crimes and certain risk of injury to children offenses.
