Title: AN ACT CONCERNING HEALTH INSURANCE COVERAGE OF ORALLY AND INTRAVENOUSLY ADMINISTERED PRESCRIPTION DRUGS.

Statement of Purpose: To require health insurance policies providing coverage for prescription drugs to provide coverage for orally administered prescription drugs on a basis that is no less favorable than the basis on which such policies provide coverage for intravenously administered prescription drugs.
