**Title:** AN ACT CONCERNING REVISIONS TO VARIOUS STATUTES CONCERNING THE CRIMINAL JUSTICE SYSTEM AND REVISING PROVISIONS CONCERNING JAILHOUSE WITNESSES.

**Statement of Purpose:** To provide for more appropriate enforcement of statute concerning unlawful employment of state officers or employees to influence legislation, to make a technical correction, to clarify provisions regarding the recording of telephone conversations at the behest of law enforcement, to provide an enhanced penalty in the case of second degree assault with a firearm, to extend protections against lockout to additional tenants and lessees, to repeal obsolete provisions concerning the state's attorney's role in the removal of town clerks and town treasurers and to repeal obsolete provisions regarding the role of the state's attorney with regard to highway construction and neglect of a highway.
