Subject: Oppose the 25% Property Tax on Nonprofits with Savings Accounts (S.B. 1137 & S.B. 1138)

Dear [recipient's salutation and name],

I strongly oppose S.B. 1137, "An Act Concerning Deposits in Lieu of Taxes," which would require tax-exempt not-for-profits pay a 25% tax on property currently exempt from taxes.

This new tax proposal, filed by the Finance, Revenue and Bonding Committee, would have a devastating impact on essential services provided by not-for-profits like The Kennedy Center and would critically erode the relationship between donors and not-for-profits.

The Kennedy Center works diligently to provide essential services to our most vulnerable populations. Philanthropic efforts ensure 2,400 individuals have basic needs met. As a community service provider, The Kennedy Center is limited to fixed rates that are not in alignment to the true cost of providing service. Philanthropy fills those significant shortfalls.

If a 25% tax is imposed on the statewide disability provider system, The Kennedy Center would be forced to lay-off employees and reduce services, thereby overwhelming state and municipal programs.

The Kennedy Center's 750 tax-paying employees empower more than 2,400 individuals with disabilities, and together contribute to our community and state economy. As not-for-profits work to solve some of the state's biggest issues through innovation they should not be penalized for having a safety net for those employees and people supported.

Any tax a not-for-profit is required to pay means fewer people will be served. This policy does not make sense, especially at a time when The Kennedy Center and other organizations are experiencing an increasing demand for services.

Simply put, this proposal would divert critical resources away from the most vulnerable people in our state. I urge you to take no action on S.B. 1137.
