Explanation

The amendment strikes the underlying bill and its associated fiscal impact.

The amendment conveys a specified 1.5 acre parcel of land from the Department of Transportation to the town of Groton. The state would lose use of an asset. The town of Groton would gain use of an asset and pay the administrative costs of the conveyance and the costs of survey, if necessary.
