### **INTRODUCTION OF BILLS HOUSE AND SENATE BILLS**

**Proposed H.B. No. 5171 REP. CUMMINGS, 74th DIST. 'AN ACT ESTABLISHING A TASK FORCE TO STUDY EDUCATION SAVINGS ACCOUNTS'**, to establish a task force to study education savings accounts.

**Proposed H.B. No. 5172 REP. GREEN, 55th DIST. 'AN ACT PROHIBITING THE EXECUTIVE BRANCH FROM MAKING RESCISSIONS OR OTHER REDUCTIONS TO A TOWN'S EDUCATION COST-SHARING GRANT DURING THE FISCAL YEAR'**, to prohibit the Governor from making rescissions to towns' education cost-sharing grant during a fiscal year.

**Proposed H.B. No. 5173 REP. LAVIELLE, 143rd DIST. 'AN ACT CONCERNING A STUDY OF FUNDING FOR EARLY COLLEGE PROGRAMS'**, to study the disbursement of state funds for early college programs offered at public high schools.

**Proposed H.B. No. 5174 REP. LAVIELLE, 143rd DIST. 'AN ACT CONCERNING THE SEGREGATION AND REPORTING OF CERTAIN HIGH SCHOOL GRADUATION RATES DATA'**, to include students enrolled in a dual high school and college degree program in a school district's annual graduation rate.

**Proposed H.B. No. 5175 REP. LAVIELLE, 143rd DIST. 'AN ACT CONCERNING A REPORT ON GRADUATION DATA FOR THE TECHNICAL EDUCATION AND CAREER SYSTEM'**, to require a detailed report on the graduation rates of students enrolled in the Technical Education and Career System.

**Proposed H.B. No. 5176 REP. LAVIELLE, 143rd DIST. 'AN ACT PROHIBITING THE DISAGGREGATION OF STUDENT DATA BY ETHNIC SUBGROUPS IN THE PUBLIC SCHOOL INFORMATION SYSTEM'**, to prohibit the collection of disaggregated student data on specific ethnic subgroups unless such student data is required by federal law or collected uniformly across the entire population of students.

**Proposed H.B. No. 5177 REP. CANDELORA, 86th DIST. 'AN ACT CONCERNING SCHOOL SECURITY AT SCHOOLS BEING USED AS POLLING PLACES ON ELECTION DAY'**, to enhance school security.

**Proposed H.B. No. 5178 REP. BOLINSKY, 106th DIST. 'AN ACT ESTABLISHING A TASK FORCE TO DEVELOP STANDARDS FOR THE DETECTION OF DYSLEXIA'**, to develop standards for evidence-based reading and writing strategies to be used for the early detection of dyslexia.

**Proposed H.B. No. 5179 REP. BOLINSKY, 106th DIST. 'AN ACT PROHIBITING THE EXECUTIVE BRANCH FROM MAKING RESCISSIONS OR OTHER REDUCTIONS TO A TOWN'S EDUCATION COST-SHARING GRANT DURING THE FISCAL YEAR'**, to prohibit the Governor from making rescissions to towns' education cost-sharing grant during a fiscal year.

**Proposed H.B. No. 5180 REP. FRANCE, 42nd DIST. 'AN ACT PERMITTING REDUCTIONS TO THE MINIMUM BUDGET REQUIREMENT WHEN A SCHOOL DISTRICT IS NO LONGER INCURRING CERTAIN SPECIAL EDUCATION COSTS'**, to allow a board of education to reduce its minimum budget requirement when it is no longer responsible for paying certain special education costs.

**Proposed H.B. No. 5181 REP. O'NEILL, 69th DIST. 'AN ACT EXEMPTING CERTAIN FACILITIES FROM THE NATURAL GAS DEMAND USE CHARGE'**, to exempt certain facilities from the natural gas demand use charge.

**Proposed H.B. No. 5182 REP. RUTIGLIANO, 123rd DIST. 'AN ACT CONCERNING SEWER USE CHARGES'**, to prevent sewer authorities from charging sewer use charges for summer water use.

**Proposed H.B. No. 5183 REP. DELNICKI, 14th DIST. 'AN ACT REQUIRING THE CONNECTICUT SITING COUNCIL TO HOLD PUBLIC HEARINGS WHEN CHANGES WILL BE MADE TO EXISTING STRUCTURES'**, to require a public hearing when changes will be made to existing structures.

**Proposed H.B. No. 5184 REP. PAVALOCK-D'AMATO, 77th DIST. 'AN ACT AUTHORIZING THE ISSUANCE OF THREE-YEAR DOG LICENSES BY TOWNS'**, to allow towns to issue dog licenses every three years.

**Proposed H.B. No. 5185 REP. O'DEA, 125th DIST. 'AN ACT CONCERNING CONSENT ORDERS ENTERED INTO BY THE DEPARTMENT OF ENERGY AND ENVIRONMENTAL PROTECTION'**, to ensure that any consent order entered into by a party

and the Commissioner of Energy and Environmental Protection, or the commissioner's designee, is not modified or revoked without the consent of the party.

**Proposed H.B. No. 5186 REP. PAVALOCK-D'AMATO, 77th DIST. 'AN ACT EXEMPTING VETERANS AND SENIOR CITIZENS FROM CERTAIN MOTOR VEHICLE REGISTRATION FEES RELATING TO THE PASSPORT TO THE PARKS PROGRAM'**, to exempt senior citizens and veterans from having to pay certain motor vehicle registration fees related to the Passport to the Parks program.

**Proposed H.B. No. 5187 REP. RUTIGLIANO, 123rd DIST. 'AN ACT EXEMPTING SENIOR CITIZENS FROM FISHING LICENSE FEES'**, to exempt senior citizens from fishing license fees.

#### FINANCE, REVENUE AND BONDING

**Proposed H.B. No. 5188 REP. O'NEILL, 69th DIST. 'AN ACT CONCERNING THE RETROACTIVE APPLICATION OF THE BONUS DEPRECIATION TAX DEDUCTION'**, to reverse the retroactive application of the bonus depreciation tax deduction enacted pursuant to section 11 of public act 18-49.

**Proposed H.B. No. 5189 REP. O'NEILL, 69th DIST. 'AN ACT WAIVING INTEREST ARISING FROM THE FILING OF CERTAIN AMENDED TAX RETURNS'**, to waive any interest arising from the filing of an amended return that was necessitated by the changes enacted to the bonus depreciation tax deduction pursuant to section 11 of public act 18-49.

**Proposed H.B. No. 5190 REP. BETTS, 78th DIST. 'AN ACT REQUIRING A STUDY OF THE ELIMINATION OF THE PROPERTY TAX EXEMPTION FOR STATE PROPERTY'**, to study the elimination of the property tax exemption for state property.

**Proposed H.B. No. 5191 REP. LANOUE, 45th DIST. 'AN ACT ELIMINATING THE BUSINESS ENTITY TAX'**, to eliminate the business entity tax.

**Proposed H.B. No. 5192 REP. KLARIDES, 114th DIST.; REP. KLARIDES-DITRIA, 105th DIST. 'AN ACT ESTABLISHING A PILOT PROGRAM ALLOWING A TAX CREDIT FOR HOSPITALS THAT MAKE BEDS AVAILABLE FOR OPIOID ADDICTION TREATMENT SERVICES'**, to provide an incentive to hospitals to make beds available for the provision of services to individuals suffering from opioid addiction.

**Proposed H.B. No. 5193 REP. DOUCETTE, 13th DIST. 'AN ACT EXEMPTING THE SALE OR TRANSFER OF PRIMARY DWELLINGS AFFECTED BY CRUMBLING FOUNDATIONS FROM THE REAL ESTATE CONVEYANCE TAX'**, to exempt from the real estate conveyance tax the sale or transfer of real property that is the grantor's primary dwelling and such dwelling is affected by a crumbling foundation.

**Proposed H.B. No. 5194 REP. DOUCETTE, 13th DIST. 'AN ACT EXEMPTING CERTAIN BUSINESSES FROM THE BUSINESS ENTITY TAX'**, to exempt from the business entity tax businesses with less than one million dollars in ordinary business income annually.

**Proposed H.B. No. 5195 REP. RUTIGLIANO, 123rd DIST. 'AN ACT REQUIRING A STUDY OF THE EARNED INCOME TAX CREDIT'**, to require the Commissioner of Revenue Services to study the income requirements applicable to the earned income tax credit and the monthly distribution, in lieu of a lump sum payment, of a personal income tax refund resulting from the application of the earned income tax credit.

**Proposed H.B. No. 5196 REP. BETTS, 78th DIST. 'AN ACT ELIMINATING THE BUSINESS ENTITY TAX'**, to eliminate the business entity tax.

**Proposed H.B. No. 5197 REP. O'DEA, 125th DIST. 'AN ACT REQUIRING MEDICAL MARIJUANA TO BE INCLUDED IN THE PRESCRIPTION DRUG MONITORING PROGRAM'**, to require that medical marijuana be included in the prescription drug monitoring program.

#### GOVERNMENT ADMINISTRATION AND ELECTIONS

**Proposed H.B. No. 5198 REP. KLARIDES, 114th DIST.; REP. KLARIDES-DITRIA, 105th DIST. 'AN ACT DESIGNATING DIFFUSE INTRINSIC PONTINE GLIOMA DAY'**, to designate Diffuse Intrinsic Pontine Glioma (DIPG) Day to raise public awareness of this type of brain cancer.

**Proposed H.B. No. 5199 REP. BETTS, 78th DIST. 'AN ACT REQUIRING PRESENTATION OF PHOTO IDENTIFICATION TO VOTE'**, to require electors to present photo identification in order to vote at their respective polling places.

**Proposed H.B. No. 5200 REP. PAVALOCK-D'AMATO, 77th DIST. 'AN ACT WITHDRAWING CONNECTICUT FROM THE NATIONAL POPULAR VOTE INTERSTATE COMPACT'**, to withdraw the state from the National Popular Vote Interstate Compact.

**Proposed H.B. No. 5201 REP. SREDZINSKI, 112th DIST. 'AN ACT CONCERNING USE OF PUBLIC FUNDS FOR POLITICAL ADVERTISING'**, to require candidates participating in the Citizens' Election Program to disclose when political communications are paid for, in part, by funds received from the program.

**Proposed H.B. No. 5202 REP. LAVIELLE, 143rd DIST. 'AN ACT CONCERNING PRIMARIES FOR STATE OR DISTRICT OFFICE'**, to move from the second Tuesday in August to the last Saturday in May the day in the year of a state election on which primaries for choosing nominees to state offices are held.

**Proposed H.B. No. 5203 REP. FREY, 111th DIST. 'AN ACT CONCERNING THE CITIZENS' ELECTION PROGRAM AND CANDIDATES WHO ARE NOT OPPOSED'**, to limit the grant of funds under the Citizens' Election Program to only those candidate committees of candidates who have opponents.

**Proposed H.B. No. 5204 REP. FREY, 111th DIST. 'AN ACT CONCERNING JOINT CAMPAIGNING AND RAISING OF FUNDS BY CANDIDATES FOR GOVERNOR AND LIEUTENANT GOVERNOR'**, to require candidates for Governor and Lieutenant Governor to jointly seek their party's nomination and jointly raise funds to qualify for the Citizens' Election Program.

**Proposed H.B. No. 5205 REP. PISCOPO, 76th DIST. 'AN ACT ELIMINATING ELECTION DAY REGISTRATION'**, to eliminate election day registration.

**Proposed H.B. No. 5206 REP. PISCOPO, 76th DIST. 'AN ACT WITHDRAWING CONNECTICUT FROM THE AGREEMENT AMONG THE STATES TO ELECT THE PRESIDENT OF THE UNITED STATES BY NATIONAL POPULAR VOTE'**, to withdraw the state from the Agreement Among the States to Elect the President of the United States by National Popular Vote.

**HIGHER EDUCATION AND EMPLOYMENT ADVANCEMENT**

**Proposed H.B. No. 5207 REP. LAVIELLE, 143rd DIST. 'AN ACT ELIMINATING THE BOARD OF REGENTS FOR HIGHER EDUCATION'**, to eliminate the Board of Regents for Higher Education.

**HUMAN SERVICES**

**Proposed H.B. No. 5208 REP. BETTS, 78th DIST. 'AN ACT REQUIRING PHOTO IDENTIFICATION FOR PURCHASES MADE WITH EBT CARDS'**, to reduce improper or fraudulent use of EBT cards.

**Proposed H.B. No. 5209 REP. PISCOPO, 76th DIST. 'AN ACT CONCERNING WORK REQUIREMENTS FOR MEDICAID RECIPIENTS'**, to promote employment and volunteerism among Medicaid recipients.

**Proposed H.B. No. 5210 REP. KLARIDES, 114th DIST. 'AN ACT EXPANDING THE KATIE BECKETT WAIVER PROGRAM'**, to increase the number of children and young adults with severe disabilities who may receive care at home under a Medicaid waiver program.

**INSURANCE AND REAL ESTATE**

**Proposed H.B. No. 5211 REP. LAVIELLE, 143rd DIST. 'AN ACT REQUIRING HEALTH INSURANCE COVERAGE FOR SMITH-MAGENIS SYNDROME'**, to require health insurance coverage for the diagnosis and treatment of Smith-Magenis syndrome.

**Proposed H.B. No. 5212 REP. O'DEA, 125th DIST. 'AN ACT CONCERNING PARITY FOR MENTAL HEALTH AND THE ALL-PAYER CLAIMS DATABASE'**, to expand mental health parity requirements, require that health carriers report additional data to the Insurance Commissioner concerning mental health parity, require that the commissioner submit an annual report to the General Assembly regarding the commissioner's efforts to ensure mental health parity, and require that the Office of Health Strategy submit an annual report to the General Assembly regarding the all-payer claims database.

**Proposed H.B. No. 5213 REP. PAVALOCK-D'AMATO, 77th DIST. 'AN ACT EXPANDING REQUIRED HEALTH INSURANCE COVERAGE FOR HEARING AIDS'**, to expand required health insurance coverage for hearing aids to individuals older than twelve years of age.

**Proposed H.B. No. 5214 REP. CUMMINGS, 74th DIST. 'AN ACT REQUIRING HEALTH INSURANCE COVERAGE FOR MAMMOGRAMS AND ULTRASOUNDS FOR CERTAIN WOMEN AT INCREASED RISK FOR BREAST CANCER'**, to require health insurance coverage for mammograms and ultrasounds, not less frequently than once annually and upon the recommendation of a licensed physician, for certain women at increased risk for breast cancer.

**JUDICIARY**

**Proposed H.B. No. 5215 REP. RUTIGLIANO, 123rd DIST. 'AN ACT EXTENDING THE STATUTE OF LIMITATIONS FOR BRINGING AN ACTION WHEN A LATENT DEFECT IS DISCOVERED IN CONSTRUCTION-RELATED WORK'**, to protect property owners by tolling the statute of limitations when a latent defect is discovered in construction-related work.

**Proposed H.B. No. 5216 REP. VAIL, 52nd DIST. 'AN ACT CONCERNING MURDER IN THE CASE OF AN OVERDOSE DEATH'**, to establish a new crime of murder for those responsible for supplying illegal drugs to a victim of an overdose.

**Proposed H.B. No. 5217 REP. CUMMINGS, 74th DIST. 'AN ACT CONCERNING THE ADOPTION OF THE UNIFORM PROTECTED SERIES ACT'**, to adopt the Uniform Protected Series Act.

**Proposed H.B. No. 5218 REP. PAVALOCK-D'AMATO, 77th DIST. 'AN ACT RESTORING THE DEATH PENALTY'**, to restore the death penalty.

**Proposed H.B. No. 5219 REP. PISCOPO, 76th DIST. 'AN ACT CONCERNING IMPROVED PUBLIC ACCESS TO CERTAIN BUSINESS RECORDS FILED WITH THE SECRETARY OF THE STATE'**, to require the Secretary of the State to enhance the CONCORD commercial records database by allowing a member of the public to ascertain the name and address of a business entity's agent for service of process by entering the name of the owner, officer or agent of such business entity in the database.

**Proposed H.B. No. 5220 REP. FISHBEIN, 90th DIST. 'AN ACT ESTABLISHING A RIGHT TO APPEAL THE DECISION OF A MUNICIPAL ETHICS BOARD TO THE SUPERIOR COURT UNDER THE UNIFORM ADMINISTRATIVE PROCEDURES ACT'**, to provide a right to appeal the decision of a municipal ethics board to the Superior Court in accordance with the provisions of the Uniform Administrative Procedures Act.

**Proposed H.B. No. 5221 REP. CARPINO, 32nd DIST. 'AN ACT CONCERNING THE STATUTE OF LIMITATIONS FOR SEXUAL ASSAULT CRIMES'**, to extend the time limitation for prosecution of sexual assault.

**Proposed H.B. No. 5222 REP. O'DEA, 125th DIST. 'AN ACT CONCERNING GOOD SAMARITAN PROTECTIONS FOR PERSONS OR ENTITIES THAT INCLUDE OPIOID ANTAGONISTS WITHIN A CABINET CONTAINING AN AUTOMATIC EXTERNAL DEFIBRILLATOR'**, to provide good samaritan protections from civil liability to persons or entities who include an opioid antagonist within a cabinet containing an automatic external defibrillator.

**Proposed H.B. No. 5223 REP. O'DEA, 125th DIST. 'AN ACT CONCERNING THE ELIMINATION OF THE COMMISSION ON HUMAN RIGHTS AND OPPORTUNITIES'**, to eliminate the Commission on Human Rights and Opportunities and redirect individuals to the existing federal agencies that provide the protections and services offered by said commission.

**Proposed H.B. No. 5224 REP. VAIL, 52nd DIST. 'AN ACT CONCERNING THE DEFENSE OF A PERSON'S HOME'**, to fully adopt the "castle doctrine" by establishing a rebuttable presumption that when a homeowner believes it necessary to use deadly force to repel an intruder then that belief is a reasonable belief.

**Proposed H.B. No. 5225 REP. VAIL, 52nd DIST. 'AN ACT CONCERNING THE DEATH PENALTY'**, to reinstate the death penalty.

#### **LABOR AND PUBLIC EMPLOYEES**

**Proposed H.B. No. 5226 REP. KLARIDES, 114th DIST. 'AN ACT CLARIFYING CERTAIN UNEMPLOYMENT COMPENSATION PROVISIONS AS APPLICABLE TO INDEPENDENT CONTRACTORS'**, to clarify unemployment tax law so that certain independent contractors are not improperly treated as employees.

**Proposed H.B. No. 5227 REP. LANOUE, 45th DIST. 'AN ACT CONCERNING THE REGULATION OF FIREARMS BY MUNICIPALITIES'**, to prohibit the regulation of firearms by municipalities.

**Proposed H.B. No. 5228 REP. PISCOPO, 76th DIST. 'AN ACT AUTHORIZING BONDS OF THE STATE FOR THE CONSTRUCTION OF A WATER LINE ON JACKSON STREET IN THE TOWN OF THOMASTON'**, to construct a water line on Jackson Street in Thomaston.

**Proposed H.B. No. 5229 REP. CANDELORA, 86th DIST. 'AN ACT DEFINING "ADVERTISING SIGN" FOR THE PURPOSES OF MUNICIPAL ZONING REGULATIONS'**, to provide a statutory definition of the phrase "advertising sign".

**Proposed H.B. No. 5230 REP. SREDZINSKI, 112th DIST. 'AN ACT CONCERNING THE POSTING OF LEGAL NOTICES ON MUNICIPAL WEB SITES'**, to allow municipalities to post legal notices on their Internet web sites.

#### **PUBLIC HEALTH**

**Proposed H.B. No. 5231 REP. RUTIGLIANO, 123rd DIST. 'AN ACT REQUIRING CLARIFICATION OF THE DEFINITION OF "COTTAGE FOOD PRODUCTS"'**, to provide clarity within the cottage food industry statutes.

**Proposed H.B. No. 5232 REP. PAVALOCK-D'AMATO, 77th DIST. 'AN ACT CONCERNING THE ADDITION OF FLUORIDE TO PUBLIC WATER SUPPLIES'**, to make it permissive to add fluoride to public water supplies.

**Proposed H.B. No. 5233 REP. O'NEILL, 69th DIST. 'AN ACT ESTABLISHING A PILOT PROGRAM FOR PERSONS WITH DIABETES SEEKING TREATMENT FOR A SUBSTANCE USE DISORDER'**, to assist persons with diabetes who are seeking help with a substance use disorder.

**Proposed H.B. No. 5234 REP. O'DEA, 125th DIST.
