H.B. No. 5229 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING THE REGULATION OF SIGNS BY ZONING COMMISSIONS'**, to authorize municipal zoning commissions to regulate the height, size, location, brightness and illumination of all signs.

REF. PLANNING AND DEVELOPMENT

H.B. No. 5643 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT REQUIRING A STUDY OF THE OBSTACLES TO MERGING OR CONSOLIDATING MUNICIPAL FIRE DISTRICTS AND FIRE DEPARTMENTS'**, to require the Secretary of the Office of Policy and Management to study the obstacles to merging or consolidating the fire districts or fire departments of two or more municipalities.

H.B. No. 6040 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT REQUIRING THE INSPECTION OF CERTAIN RESIDENTIAL BUILDINGS BY A HOME INSPECTOR AND AN ENGINEER PRIOR TO THE TRANSFER OF TITLE'**, to require owners of certain residential buildings to retain a home inspector and an engineer to prepare inspection reports concerning such buildings prior to transferring title to such buildings.

H.B. No. 6349 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT REQUIRING THE PROVISION OF INFORMATION CONCERNING CERTAIN INSURANCE POLICIES PRIOR TO THE ISSUANCE OF A CERTIFICATE OF OCCUPANCY'**, to require applicants for certificates of occupancy for new residential and commercial buildings to provide the building official with information concerning certain insurance policies.

H.B. No. 6352 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING THE ZONING OF COMMUNITY RESIDENCES AND CHILD-CARE RESIDENTIAL FACILITIES'**, to clarify how the distance between existing and proposed community residences or child-care residential facilities should be measured for zoning purposes.

H.B. No. 6754 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING REIMBURSEMENT FOR THE PURCHASE OF BODY-WORN ELECTRONIC RECORDING EQUIPMENT'**, to require the Office of Policy and Management to reimburse any municipality that purchased body-worn recording equipment during the fiscal years ending June 30, 2017, or June 30, 2018, and paid for such purchase not later than August 31, 2018, for costs associated with such purchase.

H.B. No. 6939 (COMM) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING THE ESTABLISHMENT OF MUNICIPAL CULTURAL DISTRICTS', to allow municipalities to establish cultural districts to encourage economic development and promote tourism.

H.B. No. 7396 (RAISED) JUDICIARY. 'AN ACT CONCERNING PARITY BETWEEN SEXUAL ASSAULT IN THE CASE OF A SPOUSAL OR COHABITATING RELATIONSHIP AND OTHER CRIMES OF SEXUAL ASSAULT AND CONCERNING THE INVESTIGATION OF A FAMILY VIOLENCE CRIME', to repeal section 53a-70b of the general statutes concerning sexual assault in a spousal or cohabitating relationship and to make conforming changes.

H.B. No. 7397 (RAISED) JUDICIARY. 'AN ACT CONCERNING A STUDY OF LAWS OF CRIMINAL PROCEDURE OF THIS STATE', to study the criminal procedure laws of this state.
