S.B. No. 140 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT EXPANDING ELIGIBILITY FOR TAX RELIEF FOR CERTAIN ELDERLY HOMEOWNERS'**, to provide property tax relief for certain owners of real property held in trust for such owner.

REF. PLANNING AND DEVELOPMENT

S.B. No. 361 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING A MUNICIPAL OPTION TO ESTABLISH A PROPERTY TAX CREDIT FOR DONATIONS TO CERTAIN SCHOLARSHIP PROGRAMS'**, to allow a municipality to provide a property tax credit to any owner of property in such municipality that donates to a certain scholarship program established by such municipality.

REF. PLANNING AND DEVELOPMENT

S.B. No. 522 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING ALTERNATE MEMBERS OF MUNICIPAL PLANNING COMMISSIONS'**, to permit members of municipal zoning commissions and municipal zoning boards of appeals to serve as alternate members of municipal planning commissions.

REF. PLANNING AND DEVELOPMENT

S.B. No. 527 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT PERMITTING MUNICIPALITIES TO COMBINE THE PROPERTY ASSESSMENTS OF MULTIPLE ELECTRIC GENERATING FACILITIES'**, to permit municipalities to combine real and personal property assessments of multiple electric generating facilities.

REF. PLANNING AND DEVELOPMENT

S.B. No. 548 (COMM) **PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING COMMUNITY EMPOWERMENT AND NEIGHBORHOOD ASSISTANCE'**, to (1) require certain municipalities to establish community investment boards and to use a certain percentage of grant funding received through the municipal revenue sharing account and the select payment in lieu of taxes account for the priorities of such boards, (2) require the Office of Policy and Management to establish an Internet web site for the submission of proposals for solutions to urban-area problems and authorize the Secretary of the Office of Policy and Management to establish pilot programs to implement certain proposals, and (3) establish a task force to study issues concerning nonprofit providers.

S.B. No. 1110 (RAISED) JUDICIARY. 'AN ACT CONCERNING INMATE CLAIMS THAT ARE FILED WITH THE OFFICE OF THE CLAIMS COMMISSIONER', to provide for the fair and equitable adjudication of a claim filed by or on behalf of an inmate for death or permanent injuries suffered while incarcerated at an institution or facility of the Department of Correction.

S.B. No. 1111 (RAISED) JUDICIARY. 'AN ACT CONCERNING A STUDY OF CRIMINAL LAWS OF THIS STATE', to study the criminal laws of this state.

REF. JUDICIARY

S.B. No. 1112 (RAISED) JUDICIARY. 'AN ACT CONCERNING COMMITMENT OF A PERSON FOUND NOT GUILTY BY REASON OF MENTAL DISEASE OR DEFECT', to allow the state's attorney to make application for commitment of certain acquittees to a hospital for psychiatric disabilities prior to the acquittee's discharge at the expiration of the acquittee's maximum term of commitment if the acquittee would constitute a danger to himself or herself or others or is gravely disabled.
